Excelsior Farmers Market Fee Schedule:

\$50 Membership Fee for Excelsior Growers Assn., payable to South Lake-Excelsior Chamber

Stall Fees: all fees must be paid in advance of your market participation.

Full Season:

(May-Oct.): **\$150** for Single Stall. **\$250** for Double stall
Minimum attendance of 20 weeks is required for this fee.

Half Season:

Three consecutive months: **\$95**. Minimum attendance **10 weeks** is required. *We will not hold your space if you fail to show three or more times without cause.*

Daily Stall Fee:

\$20 per day. If you are not planning to attend the entire market season, the Market Committee may accept other vendors with similar or same products to meet the customer demand. Daily stall vendors shall be assigned a stall location by the Market Manager. All other season vendors shall be assigned a stall location for the entire season.
